As per revised Schengen Rules starting from 2nd November 2015 it is Mandatory for all applicants to personally visit the VFS Centre for submission in order to complete Bio-Metric formalities.

- Passport + all old passports (**20 YEARS VALIDITY PASSPORT NOT ACCEPTED**)
- 1 Form, (Print Back to back) (2 Signature-Column No.37 & last column on 3rd page)
- 2 Photo (35 x 45 mm white background, 80% face cover)
- Covering letter address to Consulate General of France, Mumbai,
- Return Ticket
- Invitation address to Consulate General of France, Mumbai,
- Confirmed Hotel bookings.
- Last 03 years Income-tax Papers,
- Last 06 Months Bank Statements, (**Till Date updated Must**)
- Overseas Travel Insurance

If applicants from IT sector traveling for more than 30 days up to 90 days, the host organization has to get a clearance from the DDTEFP department of the French ministry in France.

Tourist:

- Passport + all old passports (**20 YEARS VALIDITY PASSPORT NOT ACCEPTED**)
- 1 Form, (Print Back to back) (2 Signature-Column No.37 & last column on 3rd page) (**For minor both parents signature required**)
- 2 Photo (35 x 45 mm white background, 80% face cover)
- Covering letter address to Consulate General of France, Mumbai,
- Return Ticket,
- Exchange / Credit card copy,
- Proof of Hotel confirmation from France,
- Overseas Travel Insurance,
- Copy of Last 3 Years Income Tax Papers,
- Original Leave letter from Company if working with Company Seal,
- Last 06 Months Bank Statement. (**Till Date updated Must**)
- For student school/ college Id card copy or Bonafide certificate
- If minor traveling with single parent or alone then Notarized NOC letter on Rs. 100 stamp paper signed by both parents is required.

Time Taken- 07-10 days after submitting documents

27 June 2013: From 1 July 2013 onwards, the French Consulate in Mumbai will proceed with a temporary suspension of biometrics for visa applications. This temporary suspension applies to all visa applicants and to all categories of visas (short-stay and long-stay).
